Real Estate Matters

L. Goodhue indicated that management is looking for authority from the Board to market and sell five properties owned by the Company in Derry, NH and Amherst, NH. Any structures (wells, pump houses, etc.) have been removed from the properties and there are no contamination issues. He reported that four out of the five properties are not buildable lots and management has determined that those lots be transferred to abutters at a price equal to the cost of closing on the transfer. A discussion ensued.

Property Located at Richardson Road, Derry, NH (Tax Map 10, Lot 62-20)
